## Text Description of Walking Routes 2022-2023

**Quadrant A** (85 E., Marsha Kaye Cir., 10920 S., Clear Creek Dr., Melissa Kaye Dr., Emilee Ct., White River Dr., Michaels View St., Cascade Pl.)

Walk to 11000 South, then walk on the north side of 11000 South, to the crossing guard. Cross with the crossing guard and walk south on 230 East on the west side of the street.

**Quadrant B** (Daisy Ridge Dr., Clover Ridge Dr. Meadow River Dr., Chestnut Ridge Dr., Green Ridge Dr., Heather Ridge Dr., Heather Ridge Cir., Sophie Ln., Hyrum Pl., 10930S.) Walk to 11000 South, then walk on the north side of 11000 South, to the crossing guard. Cross with the crossing guard and walk south on 230 East on the west side of the street.

## **Quadrant C** (115 E., Cush Ln.)

Walk to 11000 South, then walk on the south side of 11000 South until 230 East. Walk on the west side of 230 E.

## **Quadrant D** (325 E.)

Go through gate at south end of street. Follow the path by Crescent View Middle and through the park. Cross the crosswalk across 230 East and follow sidewalk to Crescent.

## **Quadrant E** (The Falls Apartment Complex)

Enter path at northeast corner of Falls Apartments. Go east on path, crossing over the canal bridge onto the southwest corner of Crescent Elementary playground.

**Quadrant F** (Crescent Pine Ln, Crescent Oak Way)

Follow north sidewalk to playground gate access.

**Quadrant G** (Jordan View Dr., Crescent Glen Cir., Crescent Park Way, Crescent Park Cir., Jordan View Cir., Crescentwood Dr., Hidden View Dr.)

Walk on Jordan View Drive and find the gate that enters school property. Continue on sidewalk to playground gate access.

**Quadrant H** (Jerand Way, La Vera Ln., Glen Croft Ln., 11200 S., Crescent Vista Ln., Vista Way)

If you are closer to Jerand Way or La Vera Lane, use those roads to access 300 East. Go north on the east side of 300 East to crosswalk near Crescentwood Village. Use crosswalk to west side of 300 East and continue on sidewalk to the entrance of Crescent Elementary. Follow sidewalk to playground access gate.

For the north end of Crescent Glen subdivision, use the crosswalk on Vista Way, across the street from Crescent View Middle School. Follow the path through the park. Cross the crosswalk across 230 East.

**Quadrant I** (Cranberry Hill Dr.(west of 300 E.), Sweet Berry Ct., Sweet Berry Dr., Sugar Berry Rd., Raspberry Ct., 150 E., Honey Berry Ct., Harvest Berry Ln., Harvest Berry Pl., Thornberry Dr (west of 300 E.)., Olive Berry Ln., Bayberry Cir., Berryknoll Cir., Heatherberry Cir., Mayberry Ct., Loganberry Ct., Cranberry Hill Ct.)

Walk to 300 East. Cross 11400 South with the crossing guard. Continue on sidewalk to the entrance of Crescent Elementary. Follow sidewalk to playground access gate.

**Quadrant J** (Chichory St., Cranberry Hill Dr. (east of 300 E.), Crepe Myrtle Cir., Brambleberry Ln., Thornberry Dr. (east of 300 E.), Honey Locust Ct., Ginger Root Ct., Mountain Berry Dr., Canabra Ct., Mapleberry Ct., High Berry Ln., Spruceberry Cir., High Berry Cir., Clear Berry Cir.)

Walk to 300 East. Cross 300 East at the light, with the crossing guard. Cross 11400 South with the crossing guard. Continue on sidewalk to the entrance of Crescent Elementary. Follow sidewalk to playground access gate.

**Quadrant K** (Heritage Apartments, Baywood Ln., Cordia Ct., Khaya Ct., Mansonia Dr., Limbali Ct., Sequoia Hills Dr., Danta Dr., Twin Ridge Dr., Beau Meadow Ln., Silver Spur Ln., Twin Pines Ct. Twin Peaks Ln., Taitlynn Rose Ln., Kimballs Ln.)

Walk on north side of Kimballs Lane to 300 East. Follow 300 East through the Cranberry Hills subdivision. Cross 11400 South with the crossing guard. Continue on sidewalk to the entrance of Crescent Elementary. Follow sidewalk to playground access gate.
